## **IDENTIFIED PRACTICE GAPS/EDUCATIONAL NEEDS**

There is a knowledge gap for clinicians and trainees in the fields of perinatal and infant psychiatry, as perinatal expertise is usually found in adult and women's health modalities, whereas infant knowledge is based in pediatrics. This separation has become an obstacle in fullspectrum treatment, especially as we have continued to learn about the profound reciprocal connection between parent and child beyond mere biology.

#### **TARGETED AUDIENCE**

This course is designed for healthcare providers, trainees, and researchers in psychiatry, psychology, obstetrics, pediatrics, primary care, and ancillary fields, who engage with mothers and their babies.
