Glen O. Gabbard, MD is Clinical Professor of Psychiatry at Baylor College of Medicine and Training and Supervising Analyst at The Center for Psychoanalytic Studies in Houston. He is the author or editor of 32 books and 365 scientific papers. He has won many awards for his contributions to psychoanalysis. In 2000 he won the prestigious Sigourney Award for his contributions to psychoanalysis, and he remains the youngest person to receive that award. In 2010 he was awarded the APA/NIMH Vestermark Psychiatry Educator Award. In 2021 he was honored with the Lifetime Achievement Award of Sapienza University in Rome. He was formerly the Director of the Menninger Clinic from 1989-1994. He also served in the role of Joint Editor-in-Chief of the International Journal of Psychoanalysis from 2001-2007. On two occasions, 2007 and 2023, he received the Adam Corneel Major Teachers in Psychotherapy Lecture at McLean Hospital in Boston. For his teaching at Baylor College of Medicine, he received the Teaching Award on 7 different occasions. His books include Psychodynamic Psychiatry in Clinical Practice, now in its fifth edition, Love and Hate in the Analytic Setting, The Psychology of the Sopranos, and Textbook of Psychoanalysis, now in its third edition.

Abstract:

The Elusive Construct of "Therapeutic Action" is one of the major sources of frustration among psychotherapeutic and psychoanalytic clinicians. The title of the presentation reflects the fact that after many decades of study and practice, it is still difficult for clinicians and researchers to adequately describe how the patient changes and what roles the clinician has in facilitating change. Dr. Gabbard will discuss historical efforts to characterize what approaches have been made to help patients expand their understanding of the source of their difficulties and what they can do improve their lives. He will illustrate some of the recent approaches with clinical vignettes.
