Weill Cornell Medicine's Department of Psychiatry is seeking a **Psychiatrist** for an Inpatient position on the Addiction Recovery Service at NewYork-Presbyterian's Westchester Behavioral Health (WBH). Located on a historic campus in White Plains, New York, WBH is a 250-bed hospital with general and specialty programs across the continuum of care. Academically oriented clinicians with a strong foundation in the evaluation and treatment of addiction and related disorders are encouraged to apply.

Psychiatrists with training in Addiction Psychiatry and experience in Medication-Assisted Therapy (MAT) for addiction recovery, including the use of buprenorphine and detoxification protocols within a rehabilitation setting, are particularly well-suited to this position.

You will care for diverse patients with a broad range of medical and psychiatric comorbidities, including but not limited to, the medical sequelae of chronic addiction, mood and personality disorders, and psychosis.

Responsibilities also include:

- Assessing and managing patients presenting for treatment of substance use disorders.
- Working within the context of a multidisciplinary team to create collaborative treatment plans, monitor patient progress, and communicate with team members to provide world-class clinical care.
- Evaluating patients for MAT, working collaboratively with staff to ensure continuity of care after discharge.
- Teaching and training the next generation of clinicians.
