### **IDENTIFIED PRACTICE GAPS/EDUCATIONAL NEEDS**

Despite the inherent connection of perinatal and infant mental health, clinicians working in each field are often not well versed in the other field or how they might be able to care and promote wellbeing for the family system including the parent and the child. Experiences of isolation, separation and connection shape the experiences and mental health outcomes for parents and infants during this time but are often understudied and not well understood. We will in particular discuss relational wellbeing in the perinatal period to increase awareness and competency for clinicians and researchers active in this area
