



## **Telepsychiatry Position**

Weill Cornell Medicine's Department of Psychiatry in conjunction with NewYork-Presbyterian Hospital, is currently seeking a qualified **Psychiatrist** for a faculty position in the Telepsychiatry Program within the Division of Emergency Psychiatry. The Telepsychiatry Program provides telepsychiatry consultation for patients presenting to the emergency rooms or admitted to the inpatient services of NewYork-Presbyterian and its enterprise hospitals. Responsibilities include providing medical leadership to a multidisciplinary team in the evaluation and management of psychiatric patients in need of emergency evaluation, management, and linkage to other services.

The schedule is rotating 12-hour shifts that includes nights and weekends. Work arrangements are flexible with the option to work either remotely or in the office (on Manhattan's Upper East Side). Remote setting must adhere to NYP remote provider policy and interested candidates upon hire must reside within 2 hours of commute to the main campus in the event of technological disruption impacting patient care.

<u>Minimum Qualifications</u>: Board certification or eligibility in psychiatry. Must possess or be eligible for a New York State license. Training in Consultation Liaison Psychiatry, Addiction Psychiatry, or Geriatric Psychiatry is highly desired.

## Salary: Minimum/Maximum salary: \$300,000
